- **B.** <u>Approval of Monthly Meeting Minutes</u>: Sarah Peacock made a motion to approve the minutes from the March 6, 2023, meeting. Motion seconded by Jennifer Vaughan. The motion carried unanimously.
- C. <u>Finance Report</u>: Stella Smith with Prestige, gave the February, 2023 financial reports. A motion was made by Jennifer Vaughan in to approve the report as information. Seconded by Sarah Peacock. The motion carried unanimously.
- **D.** <u>Foundation Report</u>: Dr. Tucker made a short report on the Foundation. He reported that Denim and Diamonds fundraiser will happen in 2 weeks on Saturday, April 22.

F. CEO Report:

- 1. Waiting List: there are 451 applications received as of April 4 2023, 102 are priority students. In

The first bus has a price of \$144,458, the second bus has a price of \$37,545. After discussion, Jennifer Vaughan waited a motion to make application to the Greene County Board of

Education for ESPLOST funds for the purchase of the two buses. Seconded by Sarah Peacock. The motion carried unanimously.

- 6. Dr. Tucker presented a proposal to purchase a replacement dishwasher and replacement ice machine for the cafeteria in the 300 Building, also using ESPLOST funds. After discussion Jennifer Vaughan made a motion to make application to the Greene County Board of Education for ESPLOST funds for the purchase of pieces of equipment. Seconded by Sarah Peacock. The motion carried unanimously. As information, is for ESPLOST funds allocated to LOA have not yet been fully drawn.
- **G.** <u>Closed Session</u>: Sarah Peacock made a motion to enter into executive session to discuss personnel matters. Seconded by Jennifer Vaughan. The motion carried unanimously.
